He is part of its Biodiplomacy Programme and champions access and benefit-sharing to genetic resources (ABS), taxonomy and biodiversity conservation. He provides expert policy and practical advice to countries on domestic and international ABS issues. Mr Burton was previously Australia's Competent National Authority on ABS and responsible for the development and implementation of its national ABS law and Policy. For 7 years he led Australia's negotiations on ABS issues leading to the adoption of Nagova Protocol. He has been published on ABS and delivered conference papers and presentations on ABS and Traditional Knowledge in Canada, Germany, Norway, Korea, Japan, Cambodia, Laos, India, Malaysia, Myanmar, Thailand, Vietnam. Timor Leste, the UK, Switzerland, France, and Brazil.

In recent years he has been delivering development assistance to Pacific countries. This has included the successful GEF Prodoc for the Cook Islands and the GEF funded Regional ABS Project for the Pacific.
